INTRODUCTION

Congratulations on beginning the journey to start your own child care business!

Child care businesses and early childhood professionals are important to the success of our economy. Quality child care help prepare the next generation for success in life and allows parents to go to work and contribute to the economy. There are many things to consider when opening your family child care business. While the process takes a lot of research, planning, and time, it is well worth the effort! And we are excited you have chosen to start this journey!

This guide is a resource to help you learn what steps you will need to take to get your business going and help it be successful.

We encourage all family child care businesses to go through the steps to become licensed; however, there are two types of family child care businesses in the state of Missouri for you to consider:

LICENSED CHILD CARE CENTER	 Programs typically care for 20 or more children at a serarate facility, often grouped by age These programs require licensing and fire and sanitation inspections
LICENSE-EXEMPT CHILD CARE CENTER	 Programs run by a religious organization or preschool programs that operate no more than 4 hours per day These programs require fire and sanitation inspections but do not have licensing inspections
LICENSED GROUP CHILD CARE HOME	 Programs typically care for 11-20 children cared for at a separate facility or an area separate from the educator's living quarter These programs require licensing and fire and sanitation inspections

CONSIDERATIONS FOR SELF-EMPLOYMENT

There are many benefits to business ownership and being your own boss, and there are some considerations to plan for before beginning this journey:

Lack of benefits

Keep in mind that in starting your own business, you will not have access to benefits like health insurance, dental/vision insurance, life insurance, retirement, or paid vacation through an employer. You will need to obtain these benefits for yourself. For health insurance, you can explore options on the <u>Marketplace</u> or through <u>Missouri's Chamber of Commerce</u> if you become a member.

Unpredictable finances

Your income can be irregular, especially in the early days. You could go several months without earning a profit if enrollment isn't full, and you'll always have to pay running costs such as rent, insurance and internet access. You will need to plan for the times when this may be the case, especially during the start-up phase.

Starting from scratch

Starting your business and then growing your enrollment can be a long, tiring and, at times, frustrating process. You'll need determination to succeed and to be able to take the initiative to keep moving forward, even if progress is slow.

Social isolation

As a business owner, and especially during the start-up phase, you may have to adjust to the increased social isolation, where you do not have the camaraderie and support of coworkers. You may have to work harder to stay motivated and connected with a peer group. Joining the Family Child Care Network can help reduce this isolation.

Increased responsibility

You will be in charge of all business decisions and outcomes. You will need to be prepared to address the increase in stress and workload this can bring.

Longer hours

Your working day may be much longer and more irregular than someone who isn't self-employed. Child care can require early mornings and later evenings to ensure the success of your program and fulfillment of all business obligations.

So, is this right for you?

Use this <u>Are You Ready to Start a Child Care Business</u> checklist to analyze if this is the right decision for you. This resource is meant to help you think about the reasons why you want to open a family child care business and if it is the right choice for you. There are personal considerations for you and your family as well as professional considerations for you to think about as you start your journey.

CURRENT CHILD CARE LANDSCAPE: ASSESS THE SUPPLY AND DEMAND OF YOUR COMMUNITY



As you begin thinking about opening your child care business, be sure to understand the needs of your community. You'll want to know the current child care options and the number of children who may need care in your area. This will be an important step in deciding if opening a child care business is the right decision for you.

Child Care Aware[®] of Missouri can help you better understand the current child care landscape in your community. Having this information will support you in the first stages of building your business plan and help you answer some very important questions, including:

- 1. What types of child care is already available in your area?
- 2. How many families with young children live in your area?
- 3. Is there a child care need for a specific age group?
- 4. Is there a need for child care during a specific time of day?
- 5. What are the typical fees (the market rate) for child care in your area?

EVALUATE YOUR SPACE: IS IT SUITABLE FOR CHILD CARE?

Finding a Location

If you are considering renting, purchasing, or building a space for your business, think about selecting an area where families live or along their route to work. A local realtor may be able to help you locate properties that would be suitable for your child care business. Before entering in to a lease or purchasing a location, you'll want to be certain that it will fit your needs and be able to pass licensing, sanitation, and fire inspections.

Check Zoning Laws

Zoning laws and local ordinances may limit your ability to open a small business in your community. These laws may affect where you can open your child care business.

Check with the local government agency in your area for guidance.

Check Restrictive Covenants



Housing developers can include restrictive covenants in deeds and homeowners' association agreements. These covenants may limit the kind of business activity that can be done in your home. Your homeowners' association has information on any restrictions. If you rent your property, check with the property owner or your community's homeowners' association about any rules.

Please note: If zoning laws or covenants do not allow businesses, you cannot open a child care business unless you get a variance (an exception to the law). This is true even if a child care program meets all the state licensing requirements.

Check Licensing Requirements

If you are interested in becoming a licensed child care program, it is important to evaluate your space to make sure it is safe and appropriate for children. You'll also want to understand what will be required to become licensed. The Department of Elementary and Secondary Education (DESE) provides a Child Care Licensing Orientation online at the link below.

The Licensing Orientation is also available in-person at all Child Care Compliance (CCC) offices. Attending in-person allows you the opportunity to meet CCC staff, receive answers to questions, and network with other potential providers. Contact your <u>nearest CCC office</u> for available dates and times.

You will want to begin familiarizing yourself with the Licensing Rules and submit an Application for Licensure. Submit your Application for Licensure early in the process so you can get connected with a local licensing specialist who can answer your specific licensing questions. If you're considering multiple locations for your business, you'll need to submit a separate application for each location. After submitting your <u>application</u> to operate a child care business, a Licensing Specialist will visit the site(s) to see if it meets the requirements to become a licensed program. They can continue to guide you through the licensing process.

License-Exempt Programs

Are you considering opening a license-exempt child care program? <u>Click here</u> to access more information on regulations and requirements. License-exempt programs must document their exemption status with the Department of Elementary and Secondary Education. These programs should file a <u>Program Evaluation Questionnaire (PEQ)</u>.

Check Health and Safety Requirements

Licensed facilities are required to have annual fire, sanitation, and health inspections in addition to compliance monitoring inspections each year. Learn more about the inspection processes on <u>DESE's</u> <u>website</u>.

COMPLETE TRAININGS AND REQUIREMENTS

All trainings that you will need to complete for licensure can be found on the <u>Missouri Professional</u> <u>Development System</u>.

Required Trainings

Safe Sleep Training: Licensed child care programs that are licensed to provide care to children less than one (1) year of age are required to complete department-approved training on the recent safe sleep recommendations of the American Academy of Pediatrics (AAP) every three years.

CPR/First Aid Training: Age-appropriate CPR/First Aid certification should be completed for all providers and assistants.

Optional Trainings

Additional optional trainings, including *Licensing Rules and Best Practices,* are available on <u>DESE's website.</u>



Comprehensive Criminal Background Check

All licensed, license-exempt, and registered providers (SOFs) are required to have all employees background checked, as well as all household members 18 years and older. This process includes fingerprinting and registering with the Family Care Safety Registry. Visit the <u>Background Check Process</u> page on DESE's website to learn more.

Mandated Reporter

All child care workers are mandated to report any suspicions of child abuse or neglect. You can complete your Mandated Reporter training by visiting the Protect MO Kids website.

Medical Examination and TB Risk Assessment

A medical examination and TB risk assessment must be completed for any child care provider, assistant, or volunteer who is present more than 20 hours per month.

DEVELOP POLICIES AND PROCEDURES

In the state of Missouri, you must have several plans and documents in place in order to become licensed. Developing strong policies and procedures allows your new program to start and run as smoothly as possible. Show Me Child Care Resources has emergency plan samples and templates, daily schedule templates and suggestions, family handbooks, and program policies.

PREPARE A BUDGET



Child & Adult Care Food Program (CACFP)

The Child & Adult Care Food Program (CACFP) may reimburse child care programs for the cost of offering nutritious meals and snacks. CACFP is operated by the Missouri Department of Health and Senior Services (DHSS) and funded by US Department of Agriculture. To be eligible for CACFP, a program must be licensed with DESE or be registered for the Child Care Subsidy program with the Department of Social Services. Missouri Child Care Subsidy Program

We highly encourage all child care businesses to register with DESE, so you can receive payment for child care services provided to families that are eligible for Child Care Subsidy.

There are a variety of benefits associated with registering to accept subsidy. By becoming registered to accept Child Care Subsidy, you may increase the number of families interested in your program. Programs accepting subsidy are also often eligible to participate in additional programs that help support the program, educators, and the children served!

LEGAL, TAX, AND INSURANCE CONSIDERATIONS

Legal, tax, and insurance considerations are important pieces in building a stable business. Please keep in mind, information provided here is not legal advice. Child Care Aware[®] of Missouri is not a tax, insurance or legal entity. You should consult with an expert for further advice on these topics.



Legal Considerations

In Missouri, there are four different business structures a business can operate under:

- Sole Proprietorship
- Partnership general and limited
- Corporation
- Limited Liability Company LLC

Research each of these business structures and determine if you will need to obtain a business license by visiting the <u>Missouri Secretary of State website</u>.

Registration forms for these structures along with information on other legal issues regarding operating a business in Missouri can also be found on the <u>Secretary of State's website</u>.

Legal resources, advice, and lawyer referrals can be found through the Missouri Bar Association.

Tax Considerations

As a small business, you will need to file business income tax information. Taxes should be a part of your child care business' plan and budget. You may want to consult with a tax professional, such as an accountant or a lawyer that specializes in business practices, to help you.



Some tax and employment benefits family child care providers can take advantage of may include: Home business tax write-offs to offset expenses Direct expenses such as food, toys, equipment, and insurance that are 100% tax deductible Indirect expenses such as real estate taxes, mortgage interest, rent, utilities, etc.

Insurance Considerations

Business insurance is not a licensing requirement, but a general recommendation is that you have appropriate business insurance and have an agent that checks in with you at least once a year to evaluate any changes within your business. You may need to consider insuring your business to cover property, general liability, and child accidents.

Property insurance covers the building, contents, and business income. Property insurance protects your property from things like fires, hail, windstorms, tornados, and water overflow and/or backup, depending on your policy and coverage selected. General liability insurance covers your business in case of things like a slips/fall of visitors, improper supervision, negligence, or leaving a child unattended. Additional options you might want to discuss with your agent is coverage in case of a slip or fall of child or other child accidents.

HIRE STAFF

The size and capacity of your child care business will help determine the number of staff members you will need. For licensed child care programs, you must follow the adult to children ratio requirements outlined in <u>Missouri's licensing regulations</u>.

You'll also want to be sure the Director you hire meets the <u>Director Certification Qualifications</u> for the size of your program.

Missouri Accreditation of Programs for Child and Youth (MOA)

Missouri was the first state to establish and apply quality accreditation standards for programs providing care and education for children. Missouri Accreditation (MOA) works to enhance the physical, social,

emotional, and intellectual growth opportunities available to children in early learning and school age programs across Missouri. MOA provides ongoing monitoring, evaluation, and recognition of programs who have met and maintained Missouri Accreditation standards. Accreditation criteria include the areas of children's relationships and interactions, physical environment, programming and curriculum, family and program connections, administration, as well as health, safety, and nutrition.

National Association for the Education of Young Children (NAEYC)

The National Association for the Education of Young Children (NAEYC) works to support high-quality, research-based education to provide a solid foundation for all children's future success by implementing quality-improvement resources, research on best practices, training, and technical assistance to licensed child care centers. NAEYC addresses three core areas within its accreditation process—children, teaching staff and administration, and families and community relationships. In looking closely at these three areas, NAEYC examines the way children are influenced by their educational leadership and family and community relationships. Each piece is evaluated at the NAEYC standard level in order to determine their accreditation achievement.

National Association for Family Child Care (NAFCC)

For over 25 years, the National Association for Family Child Care has worked to promote high-quality early childhood experiences and prioritize access, affordability, and quality of early care and education specifically in the licensed family child care environment. The NAFCC strives for progress in the investment and implementation of the Child Care and Development Block Grant, Early Head Start-Child Care Partnerships, and the Child and Adult Care Food Program in the Child Nutrition Reauthorization. Other core focuses include strengthening the early childhood workforce and increasing the availability of high-quality child care in rural communities, for infants and toddlers, and for families who work non-traditional hours.

National Early Childhood Program Accreditation (NECPA)

National Early Childhood Program Accreditation (NECPA) can be applied to family child care and center-based programs who are licensed for seven or more children. It works to improve the quality of early care and education programs. NECPA standards are based on 30 years of research in the area of early care and education. NECPA standards aim to address the whole child by assessing relationships between the child and teacher, the program and family, and the program and the community.

Commission of Accreditation of Rehabilitation Facilities (CARF International)

The Commission of Accreditation of Rehabilitation Facilities (CARF® International) works with diverse environments through an accreditation process and ongoing progress review that focuses on improving the lives of the individuals served. CARF works with different health and human service institutions like rehabilitation programs, treatment programs for addiction and substance abuse, home and community services, and retirement living. CARF accreditation requires institutions to meet its standards related to business and service delivery and to commit to ongoing improvement. Accreditation is evaluated annually based on standards set forth collaboratively by professionals and consumers of different viewpoints.

Council on Accreditation (COA)

The Council on Accreditation (COA) is an international peer accrediting body that works with human service programs and organizations, including child and youth development programs, to produce high-quality, measurable results focusing on growth, stability, health, and safety. COA considers the consumers, staff, board, and donors, funders, and regulators to be the four key groups to examine when establishing accreditation.

Cognia (Formerly AdvaceED)

Cognia (Formerly AdvancEd) works with early childhood institutions to improve teaching and learning as well as health and safety to better support early learning, growth, and development. It utilizes researchbased and evidence-based principles to examine how the policies, practices, learning conditions, and cultural setting work together to reach the program's vision and meet the needs of every learner. It focuses heavily on a program's ability to sustain an exemplary commitment to continuous progress and learner outcomes.

Breastfeeding Friendly Recognition



Breastfeeding gives moms and babies many health benefitsyet many moms worry that going back to work will make it hard to breastfeed. Helping moms continue to breastfeed can be done with just a little time and resources. Becoming a <u>Breastfeeding Friendly Child Care</u> is a voluntary recognition program available to Missouri child care facilities to show your support of breastfeeding mothers.

MOve Smart Child Care Recognition
